RESOLUTION NO. 144-08

THE CORPORATION OF THE
TOWN OF ARNPRIOR

BY-LAW NO. 5628-08

BEING A BY-LAW TO AMEND BY-LAW NO. 4989-01 BEING A BY-LAW TO MAINTAIN AND OPERATE A WASTE MANAGEMENT SYSTEM AND SERVICES WITHIN THE LIMITS OF THE TOWN OF ARNPRIOR.

BE IT THEREFORE ENACTED AS A BY-LAW OF THE CORPORATION OF THE TOWN OF ARNPRIOR:

1. THAT in Section 1.0 **Definitions**, the definition “Yard Waste” be deleted in its entirety and replaced with the following:

“Leaf and Yard Waste” shall mean and include plants and flowers, compost, leaves, grass clippings, tree/shrub trimmings and small branches (less than 1.5” diameter).

“Brush” shall mean shrubs, hedges, trees, large branches (greater than 1.5” diameter), roots, timber, and logs.

2. THAT in Section 2.0 **Waste Collection – Garbage and Refuse** under Frequency of Collection (2.1) the following policies be added:

As the 3rd paragraph (new paragraph)

“Leaf and Yard Waste” will not be collected during weekly curbside Garbage and Refuse collection. “Leaf and Yard Waste” will be collected only during designated “Leaf and Yard Waste” collection days set by the Corporation of the Town of Arnprior. Arnprior residents may take “Leaf and Yard Waste” to the landfill site using their own transportation whenever the landfill is open. Disposal is free for “Leaf and Yard Waste”. It is mandatory that “Leaf and Yard Waste” be separated at the landfill site and be placed in the designated area.

Residents are encouraged to use home composting methods for disposal of “Leaf and Yard Waste”

As the 4th paragraph (new paragraph)

“Brush” will not be collected during weekly curbside Garbage and Refuse collection or during “Leaf and Yard Waste” collection days. “Brush” may be transported to the landfill site using personal transportation whenever the landfill is open. “Landfill Tipping Fees” apply, or a “Free Landfill Voucher” may be used as a method of payment for disposal of “Brush”. It is mandatory that “Brush” be separated and placed in the designated area at the landfill site.




