Purpose and Effect of the 5-Year Review of the Official Plan

The Town of Arnprior is reviewing its Official Plan approved in 2000, as mandated by Section 26 of the *Planning Act*. The intent of the update is to address local land use planning issues facing the Town and to ensure policy changes continue to have regard for matters of provincial interest and are consistent with changes to the Provincial Policy Statement issued under the Planning Act.

The Background Study reviews and analyses comprehensive demographic and technical planning information, services and facilities located in the Town of Arnprior and considers the Town's Strategic Plan. This detailed review will assist in updating the goals and objectives for land use and development policies in the Town of Arnprior.

The Issues and Options Report highlights issues and policy options arising from the information collected in the Background Study and changes to Provincial legislation. It is intended to start the discussion on required changes to land use planning policies for the Town that will be addressed in an amendment to the Official Plan.

The Official Plan affects all lands within the Town of Arnprior therefore, a Key Map has not been provided.
